What is P3?

Personalized Prescription Plan

The Personalized Prescription Plan (P3) is an employee benefit that provides your employees and their families with affordable genetic testing designed to personalize their prescription medications.

P3 helps both employers and their employees in the following ways:

- ✓ Saves money on medication waste
- ✓ Less employees on disability
- ✓ Less medication-related absenteeism
- ✓ Increased employee productivity and morale

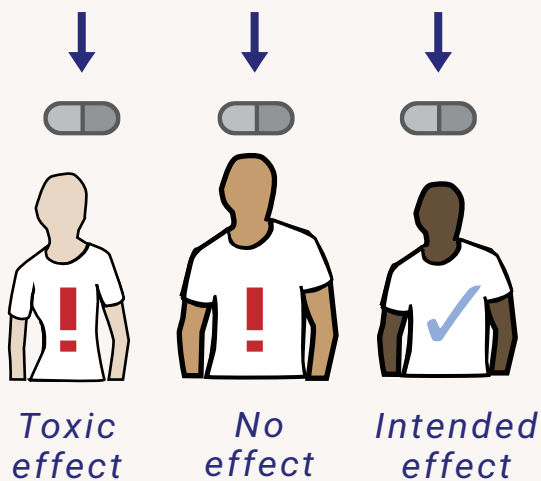
The Science Behind P3

P3 works by identifying these unique genetic differences.

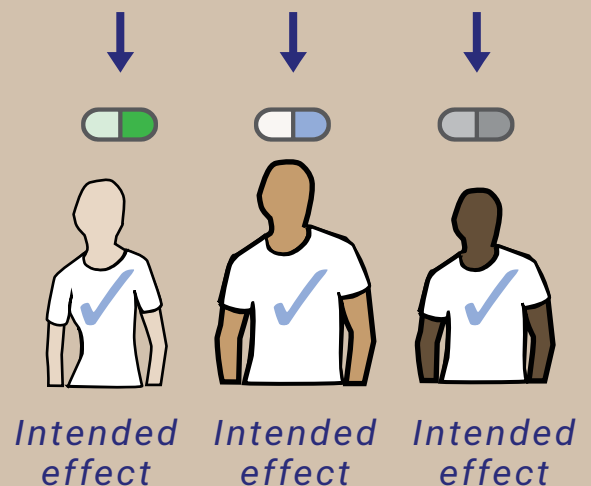
WITHOUT P3

P3 can enable your employee's doctor to:


- ✓ Lower the dose of their medication to reduce side effects
- ✓ Increase the dose of their medication to improve the drug's efficiency
- ✓ Switch to a different drug that may work better

P3 provides a report with recommendations that have been clinically validated by at least one of the two leading consortias:

Clinical Pharmacogenetics Implementation Consortium (CPIC), and

Dutch Pharmacogenetics Working Group (DPWG)

All testing is conducted at a state-of-the-art genetic laboratory that operates under the *current Good Laboratory Practice (cGLP)* guidelines set by Health Canada.

Plan Options and Eligibility

STRICT PLAN

BASE RATE: \$0.75/EE/MO

Employees and their dependents are eligible for the test when they are prescribed or are currently taking a medication on our Drug List AND are experiencing difficulty with their medication.

STANDARD PLAN

BASE RATE: \$2/EE/MO

Employees and their dependents are eligible for the test when they are prescribed or are currently taking a medication on our Drug List.

FLEXIBLE PLAN

BASE RATE: \$3/EE/MO

Employees and their dependents are eligible for the test when they are prescribed or are currently taking a medication on our Drug List – OR if they are prescribed a medication NOT on our Drug List but which has therapeutic alternatives on our Drug List.

CO-PAY

Employees and dependents who are non-eligible under any plan may purchase the test at a significantly discounted rate.
